ANNUAL REPORT 2008-09

ASHWINI's vision is to have a health programme for the tribals of the Gudalur Valley that is accessible, acceptable and owned by the tribal community. We believe that ownership of institutions helps in empowering communities.

The last year was one of growth. Construction of the new building for the Gudalur Adivasi Hospital was in full swing. There was a lot of excitement as the first block was nearing completion. Volunteers from villages as well as staff did a number of "work camps". The team spirit was remarkable and the sense of ownership of the community was very visible.

The patient profile: There was a significant increase in the number of both In Patients and Out Patients this year. The dental wing has also been more active with Drs Manju and Mahantu being here full time.

Health Indicators: 66% of 312 deliveries among tribal women were in hospital this year. This is a notable achievement, considering that only a handful would come for antenatal care just a few years ago.

Unfortunately, one mother died in delivery. Shantha with twins had been transferred to Coimbatore Medical College for delivery. She died of bleeding there - a totally unacceptable maternal death! There were 11 Infant deaths this year, making the Infant Mortality Rate 38.7/1000, well below the Indian rate of 67/1000. The Community Mental Health Program is a true success story, many families have been helped. There is a very high level of awareness about mental illness in the community. 227 patients are on treatment.

Government Programs: The Tamil Nadu Government continues to support In-Patient care

through the "Bed Grant program". The mobile clinic makes daily visits to the villages with the health animators. 7558 patients were seen. 3068 people were screened this year for sickle cell disease. Currently, 180 patients are on treatment. The HIV testing and counselling centre is also fully functional.The TANSACS team with the project director Supriya Sahu visited ASHWINI to understand the problems faced by the



tribal communities and to plan interventions.

The Medical Student Elective Program, supported by Charities Advisory Trust, UK is very popular. 12 students from different countries participated this year.

The Adivasi Munnetra Sangam membership has increased to 16057 people (2598 families).

Five New Trainees have joined the program to be trained as nurses. The two from the previous batch are taking on a lot of responsibility now. Indicorps volunteer, **Abirami** trained this new batch, besides putting together an elaborate "Nursing Manual". Dr.Clement, who worked with us for 2 years, has completed his rural bond and gone for higher studies.

The Dr. K.S Sanjivi Award for Best Institution in 2008 was given to ASHWINI by CIOSA and Udhavum Ullangal, Chennai.

New Building Construction: The first block is nearing completion, the canteen has been completed. Work on the meeting hall and the resident doctors' quarters have been kept in abeyance due to lack of funds. We need another 16,00,000 (32,000\$) to finish this. Your generous support was reason for our getting this far. Do help us to complete the project.
