ANNUAL REPORT 2014-15

The vision of ASHWINI is to have a Health System for the tribals of the Gudalur Valley that is accessible, acceptable and owned by the community. ASHWINI was registered as a Charitable Society in 1990.

We are proud to say that we are well on our way to achieving this dream. The infrastructure of the 50 bed Gudalur Adivasi Hospital is mostly in place, with more than 50 tribal staff playing key roles in the running of the Health Program. The majority of the ASHWINI Society members are from the tribal community and there is significant participation and volunteering of the community members in many aspects of the program.

The Hospital witnessed considerable activity this year. The continued support of volunteer doctors helped increase the services provided. Ultrasound, Endoscopy & X rays units were well utilised. A Screening Program for cancer of the cervix and breast was started. 1,290 patients were screened. There was no cancer of the breast; but in the tribal community itself, four early cervical cancers were detected.

The Blood Bank license was obtained and it has started

functioning. Many more complicated surgeries were performed this year, thanks to visiting specialist doctors, good operating rooms and equipment. The Disability Centre has registered 208 clients and has distributed 14 hearing aids so far.

The Community Health Programme

The health indicators have improved this year. Malnutrition in children continues to be a problem. Alcoholism in the community is affecting children the most and unless this is addressed, it is likely that the health of the children will continue to deteriorate. More than 90% of the deliveries took place in an Institution this year; maternal care has overall improved.

The presence of tribal counsellors in the PHCs has greatly improved the utilisation of the PHC

services by tribals. Counsellors work with the ASHWINI team and report to them. This has helped to improve the confidence of the tribals in accessing the Government health system.

A survey on the prevalence of diabetes in the community was carried out. The results of the analysis are awaited.

Training programmes:

11 new students enrolled for the various courses (Nursing, Pharmacy, Lab technician, Office and Accounting) conducted by the hospital.

2 students successfully completed the 2 years Lab Technician diploma course and 1 student the Nurse Anaesthetist course at Jeyasekharan Hospital in Nagercoil and have joined as staff at GAH.

Two tribal girls from the Paniya community got admission for B Pharm and Physiotherapy courses respectively. They are being supported by scholarships under The Poristes Grant. One boy has joined the Computer Diploma course in Bangalore

Many students from universities abroad, CMC Vellore, TISS Mumbai, Martin Luther Christian University Shillong and other colleges spent time

at ASHWINI doing internship or elective work. The feedback from the students has been very positive.

Government programmes

The "Bed Grant" and Sickle Cell programs continue under TNHSP. Village level screening for Sickle Cell disease, also under TNHSP, has been completed and presently testing is limited to newborns and OP&IP patients , who missed the village screening,. Free treatment for the Sickle Cell patients is being provided.

Staff

Dr Renita, a surgeon spent part of the last year at GAH. We had many volunteers helping -. Dr Kathryn,a General Practitioner from UK, Dr Robert and Dr.Isabella, Gynaecologists from Switzerland, spent a year with us. Ms Jodi developed the garden and did some

Funding Support

The Navajbai Ratan Tata Trust's support to meet deficit funding for the hospital continued this year.

A corpus fund of Rs 15 million has also been set

up by NRTT to fund this in the long term.

The Cognizant Foundation, India gave a grant to procure the equipment for a Blood Components Bank. Poristes Stiftung continues to support the Training Programs.

AID Pittsburg supported part of the costs for the Training Program.

ATMA (American Tamil Medical Association) continued their support provided equipment for the ICU.

The Government reimbursed the costs of In-patient care for tribals as well as the Sickle Cell Program. The UK charity "From Here to There", Tribal India Health Foundation and Vidyalaya.org in the US continue to support us.

Significant donations were given by some of our friends this year. Many individual donors have also been supporting us through GIVE India.
